HIRING OF CLASSIFIED PERSONNEL All classified personnel openings will be advertised in accordance with District Policy and the LKNEA Classified Negotiated Agreement. The Superintendent or his/her designee shall provide the ASB the information as to the requirements of the LKNEA Negotiated Agreement upon request. These procedures will include both the ASB and Site Administrator in the hiring process and will conform to State and Federal requirements. Unless the LKNEA Negotiated Agreement requires that a current classified employee is entitled to a hiring preference, or that a person is entitled to recall rights after layoff. The Advisory School Board and Site Administrator will select a new hire using one of the following options:

1. From the pool of applicants, the Advisory School Board will interview and select two or three applicants for the Site Administrator to consider for the vacant position.

2. From the pool of applicants, the Site Administrator will interview and select two or three applicants for the Advisory School Board to consider for the vacant position.

3. The Advisory School Board may delegate the hiring of a new classified staff member to the Site Administrator.

Each year the Advisory School Board working together with the Site Administrator will establish a pool of persons to be drawn from to fill temporary positions (LK-NEA Article I.S.). Except in emergency situations, temporary positions should be filled from this pool.
